* JH has spoken to OCC Highways who have stated that as no accidents have been recorded in the village, they will not support a 20mph speed limit. JH has researched various signs (which are non enforceable) with the '20's Plenty' one proving most expensive. It was agreed to purchase 2 x 'Please drive Slowly' and 1 x 'Camera' sign. Cllr Arash Fatemian had previously agreed to arrange for speed strips to be placed on the road to record speeds but no action has been taken.

ACTION : JH to arrange purchase of signs

ACTION : CF to remind Cllr Fatemian and also to provide JH with details of the contact at OCC who can arrange for installation of the speed strips.

** There was some confusion on this action. Information had been received regarding the Community Heartbeat Trust who provide support to anyone who may require the use of a defibrillator, and in such a situation should not be left alone. Community Heartbeat Trust require the names of 10 people in the village who would be able to assist in a situation to ensure the victim in not left alone. The names of people currently on the village list can be used but more are required.

*** Ian Gray has confirmed that his security camera only covers his drive and not the road, so would not pick up any number plates or images of drivers.

05.19.06 Updates

a) Playground Advisory Group

Although not at this meeting, Lucy Cornish reported that all equipment outside the fenced area apart from the large slide is to be replaced. The Oxfordshire Playground Group has advised replacing all the equipment and has provided details of grant funding from Viridor which Lucy is pursuing. Lucy will be stepping down as Playground Group Leader in September and a replacement for her is being sought. She will continue with the funding application and act in an advisory capacity to anyone who may take over from her as Leader.

b) Nancy Bowles Wood Advisory Group

Tim Vincent reported :

- In February 2019 we again had a work party up in the wood. Five volunteers from the Advisory Group coppiced three more hazel trees. All three are showing good signs of regrowth. This brings to about 20 the number of hazels coppiced over the past four years. All but two have regenerated very well and most of the deer guards have now been removed as the new shoots grow above grazing height.
- An additional tree in the glade was also coppiced this year. Although not a hazel this tree had a severe lean as a result of another larger tree falling on it during Storm Doris in 2017. It is hoped that by removing the heavy leaning stems, over which gravity would eventually have triumphed, the regrowth will be strong and vertical. This tree too is regenerating well.

Jane and Ken Clifford have planted a memorial tree near the glade in memory of their son Sam. Over the winter period the picnic bench was removed, cleaned and repainted. This is now back in the wood.

The childrens woodcraft group has continued to meet up in the wood once every two weeks.

- The wooded fence in the glade overlooking the valley was installed many years ago when the wood was first planted and has been patched and repaired many times since. It finally reached the point of no return and has now been replaced by a cleft-chestnut post-and-rail fence.
- The grass in the glade will continue to be cut during the summer months as required to maintain the glade as an open area.

05.19.07 Water level of the pond

There was concern regarding the water level in the pond. This could be because of the water level in the well and it was suggested that the stones in the well should be removed to increase the level. It was thought that this could be a hazard for children and it was agreed that a grid should be put over the top of the well.

ACTION : NO to speak to Richard Kyte to arrange for a grid to be placed over the well.

05.19.08 Charity clothing bank

To emails had recently been received, one from the Childrens Air Ambulance and one from Scope requesting that the parish council support the installation of clothing banks in the village. Similar requests have been made in the past and the PC has always refused. After some discussion it was agreed that if there was to be a clothing bank the PC would prefer to support the Childrens Air Ambulance. After further discussion it was agreed that residents would probably not use a clothing bank, but may be happy to donate to a twice yearly bag collection.

ACTION : CF to respond to Scope declining the request and to the childrens air Ambulance suggesting a twice yearly bag collection instead of a clothing bank.
