08.18.07 Grasscutting

Countyrwide have cut the football pitch in the past but not to a very good standard. Dunn & Sons have mowed the pitch but have stated that in future to cut the surround (BTFC will maintain the pitch) to the required length of 1 1/2" the price will be increased due to the time it will take to alter their equipment.

08.18.08 Football

Brackley Town Football Club (BTFC) have now signed the agreement with SPC for the use of the football pitch. The agreement is for 2 years with an option of renewal for a further 3 years. They have measured the pitch and found it to be not of regulation size and the goalposts are too big so they may replace them. They will replace the toilets and sink in the changing room and have the area professionally cleaned in the near future and will eventually replace doors and redecorate the changing rooms. They will pay for the mowing and maintenance of the pitch. An enquiry had been received from Brackley Town ladies team for the use of the pitch but it has been decided not to pursue this.

08.18.09 McDonalds

Following the issues with smells of sewage in the village, the franchisee for McDonalds, Joanne Jones, had emailed outlining her actions to resolve the situation. The manufacturer of the drainage unit is reviewing the levels of chemicals being used and the problem seems to have been resolved. Joanne has further invited PC members to visit the restaurant and is keen to build a good relationship with the PC. NO will visit her at the restaurant.
