# **03.19.01** Apologies

#### 03.19.02 Declarations of interest

There were no declarations of interest

# 03.19.03 To receive the minutes of the last parish council meeting

The minutes of the parish council meeting held on 15th January 2019 were checked for accuracy and content, agreed as a true record of the meetings and signed by the chair.

# 03.19.04 Public participation

Members of the public were invited to participate.

Norma Jones asked why a small oak tree has been planted on common or charity land by The Pound. David Blunt has planted it as he has removed it from his field as previously agreed. It was previously agreed that Audrey's plaque would be placed on the tree, but this is now on an apple tree.

# ACTION: NO to speak to Tim Vincent to see where he wants the oak tree and arrange for it to be transplanted.

Norma Brown also expressed thanks for replacing the slate on the bus shelter, and enquired about the bollards. The bollards are in the shed waiting to be installed once a working party has been established.

Mandy Sweetman expressed her concern about speeding vehicles in the village.

# ACTION: JH to look into options of SID devices and 20's plenty signs and report back to the next meeting.

Katy Draper reported that she has information regarding a Village Emergency Telephone System which would assist in an emergency if a patient was alone and required the defibrillator. This system is quite expensive and there is a list of volunteers in the village who would respond in an emergency. There was discussion about the use of Facebook/WhatsApp.

**ACTION**: NO to check the current list is up to date.

### 03.19.05 Clerks Report and Actions from previous meeting

There were no actions from the previous meeting.

#### **03.19.06** Elections

The clerk provided copies of nomination papers and elector numbers where required. Nomination papers are due to be submitted to CDC by Wednesday 3rd April at the latest.

Chris Rothero informed the council that he would not be standing for election this term. He has been a councillor for over 30 years.

#### 03.19.07 Trees

**Gibbs Field House** - David Blunt has raised the issue of ownership of 5 willow trees at the bottom of Foxhill Lane. He purchased land from Richard Deeley but is uncertain where the boundary is. According to CDC maps 4 out of 5 of the willows are on common land and therefore the responsibility of the parish council. In the past OCC have pollarded the willow trees, when requested, but Mr. & Mrs. Blunt would prefer the trees to remain as they provide a shield to their property. The willows are included in the quote from Nicholsons and would cost £1600 + VAT to be cut. Mr & Mrs Blunt have paid for maintenance of the willow that is in the middle of the ditch ( which would infer it is on their land and therefore their responsibility). It has been agreed that no maintenance on the trees would be carried out without consulting the Blunts first.

A separate survey of the trees in the churchyard was carried out by Nicholsons. It is not clear if the PC have been informed that the churchyard has been officially declared closed (and therefore becomes the PC's responsibility). NO has sent Clive Smith the tree survey and requested that he provides positive proof that the churchyard has been declared closed. In the meantime any remedial work due to be carried out will be held in abeyance.

The memorial plaques which have recently been put on the trees are already beginning to show signs of deterioration and will need to be examined.

ACTION: NO to look at the guarantee for the plaques as they were expensive and should not be deteriorating so soon

A quote had been received from Nigel Prickett for grasscutting in the village.

#### 03.19.08 Councillor Responsibilities

NO had circulated a list of items for which the PC is responsible and asked all councillors to consider which could be their area of interest and which they would

lead on and to report back at the next meeting. Once decided, this information would be published on the website so members of the public know which councillor to contact for a particular issue.

# 03.19.09 Security Cameras

CF had emailed the local PCSO who had confirmed that Thames Valley Police could have no involvement with security cameras in the village. KA had spoken to Banbury Arials who could provide a security camera, possibly mounted on the village hall, at an approximate cost of £2000. Other local villages have installed cameras and a reduction in burglaries has been noticed. Ian Grey has a camera on his property and NO will speak to him to ask if his camera could be accessed if necessary. There is a WhatsApp group, Souldern Alerts, which some people belong to and are alerted, for example, if the scrap metal dealers are in the village.
