Matters arising

Flooding - Following heavy rain, rainwater ingress to the sewage system caused flooding in several properties in the village. OCC Highways cleared the storm drains. Thames Water are due to survey the sewage system this week. **MKB will chase Neil Whitten, Environmental Officer for OCC, if no action is taken.**

Speeding

Sadly a cat was killed on the road recently as a result of a speeding vehicle. It is believed that most of the speeding incidents are caused by independent delivery drivers, e.g. Yodel and not supermarket delivery drivers.

Electric vehicle charging point

NO has been put in contact with OCCs Lead Strategist, but as yet no strategy for electric vehicle charging points in villages has been developed.

09.20.06 Updates

a) Playground Advisory Group

It has been reported that there is a wasps nest in the playground. NO to deal with it.

The netting around the big slide which has been closed is no longer there. AS to create sign informing that the slide has been closed, is dangerous and must not be used.

b) Nancy Bowles Wood Advisory Group

c) CDC

MKB reported that CDC are working on a revised balanced budget as a result of Covid19. Central Government may not provide additional funding and work is on going on next years budget.

Amendments to the Cherwell Local Plan have been passed with the green belt area around Kidlington approved.

The Local Plan amended by MCNP is being revised with consultation on what should be covered extended to 29th September.

A supervision Board has been formed to ensure parishes are represented on planning applications. MKB is on the panel.

Details of the Government White paper have been published which could involve reorganisation of counties and districts over a period of several years.

The Heyford Park Master plan including proposals for the Bus Gate at Middleton Stoney will be considered and MKB commented that there is considerable village opposition to the Bus Gate.

MKB mentioned that the paperwork for grant application for Covid funding had not been received - NO to chase.

d) OCC

AF reported that OCC has a budget shortfall of £16m out of a total of £500m, some of which is caused by Covid and some due to lack of income (e.g. parking fees due to people working from home)

The county is considering Unitary proposals as government have found, particularly during the pandemic, that dealing with so many layers of authorities has been problematic and there is scope for streamlining.

AF commented that he was aware of the recent flooding issues in Souldern and had offered assistance, and that the recent request for funding of bollards had been paid.
