#### e) Pond cottage

There was considerable discussion around events at Pond Cottage. The cottage flooded in August 2020 resulting in the owners having to move out. In March 2021 there was an oil leak from a pipe connected to the oil tank, resulting in oil discharging into the surrounding soil, the pond and the canal. Subsequent investigations have revealed that in March 2014 an email was sent to the PC requesting permission for a pipe to be laid across the PC's land to discharge into the pond. There is no evidence of a response from the PC nor any paperwork from CDC, OCC, The Environment Agency or Thames Water. The area has now been excavated and pipes have been found to be going from below the sunroom into a manhole leading to a well and then into the pond and therefore any contamination is going into the pond also. There is still a smell of oil and oil can be seen on the surface of the water. The fish appear to be thriving. A new oil tank is to be installed. Malcolm Streetman was present at the time the manhole was being built and will place a marker to show where it is.

JH will draft a letter to the current owners informing them that permission was never given by the PC and requesting sight of any documentation they have from other bodies.

NO will attempt to find out how to get tests done on the water in the pond, the well and the manhole.
