## 04.24.06 Co-option of councillors

There are still 2 vacancies. Requests have been made on WhatsApp and noticeboards with no response. It was agreed that a direct approach is the only way to encourage applications and all councillors were asked to consider anyone they know who might be interested.

## 04.24.07 Correspondence

- CRT re Lifting Bridge . A response to the letter sent indicated that signage has been put up around the bridge requesting users to put the bridge down after use. A log will be kept during the summer to record times when the bridge is left up and will be sent to CRT.
- Sanctuary re 4 Bovewell A letter had been received from a housing officer, indicating that she had visited on several occasions and had a conversation with the resident and found no grounds for complaint. It has since been noticed that vehicles have been removed from the premises
- Diana Stevens re dry stone wall by playing field. An email had been received expressing concern about the wall. NO has inspected it and agreed that it is in danger of collapse. Malcolm Sweetman has offered to carry out repairs for £250. It was agreed that NO will ask him to proceed.

#### 04.24.08 Playground Insurance update

NS has spoken to the insurance company and they confirmed that public liability cover is in place provided regular inspections are made by someone appointed by the council and recorded. JH said that Gallaghers have said that reference should be made to the Design Document. JH also said that the Kompan design document states that the playground is designed for under 12s.

There was lengthy discussion as to whether appropriate precautions have been taken and whether the insurers would honour a claim if a claim was made by someone of inappropriate age using the equipment.

NO will carry out investigation of other playgrounds and their signage. NO will also ask Alan Smith if he carried out any signage research prior to the playground build.

#### 04.24.09 Trees by NBW

A resident is intending to pollard the willow trees at the bottom of Foxhill Lane outside his house, some of which are owned by the parish council There is a schedule of trees prepared by Nicholsons in 2019 identifying the trees. JH will speak to the resident asking him to identify the trees he believes are his.

There is an Ash tree on the outskirts of the boundary of Souldern Charity's hedge near the allotments. It is suffering from Ash Dieback. JH to identify location using W3W and Clerk to report to CDC asking for advice
