Correspondence

A member of the public Whatsapped NO requesting his sons U8 team to use the football pitch - NO checked with BTFC who are happy for it to be used.

Correspondence was received by NO from another resident asking if an U15 used the football field on Sunday mornings when the ladies team is not using it. This was discussed and it was agreed to agree to the request on a trial period providing behavior and language is acceptable (due to previous experience of complaints)

The same resident had sent correspondence regarding the electricity bill for the changing rooms. The meter needs changing and it was agreed that **NO will make** an appointment with SSE.

An email had been received from a previous resident of Hackertys Way asking about the state of the building and whether it is lived in. NO has responded.

The village hall will need to request a donation from the BTFC toward the water bill which has almost doubled and is not metered.

## 07.24.08 Reports from County/District Councillors

Cllr Fatemian had submitted a written report ahead of the meeting,

Cllr McHugh reported that Somerton PC had asked for a road sweeper to clean the village, which was provided, and suggested that Souldern may also benefit from this. It was thought this is a good idea and a suitable date will be identified when vehicles can be kept clear from the road.

Traffic from Soho farmhouse is affecting many villages and speeding is a problem. Cllr McHugh is drafting door to door flyers and also a survey monkey to record views of the residents and wondered if Souldern would be interested in such a campaign. NO explained that this had been tried in the past and that the greatest culprits for speeding are delivery drivers,

He also mentioned that Tooleys boatyard in Banbury are running a series of fun days on Saturday throughout the summer which can be booked via the website and proceeds will go to charities.

#### 07.24.09 Playground

HD had spoken to Alan Smith regarding putting bark around the tree climber and slabs around the bench. Alan has agreed to these suggestions and is prepared to undertake the work on both items. It was agreed to ask Alan to lay the slabs but hold off on the bark.

# 07.24.10 Trees by NBW/Ownership of land

A letter had been sent to Mr & Mrs Blunt offering a meeting next week. Mr Blunt has agreed to the meeting, but wants responses to his queries in his last letter before the meeting. **HD will provide him with the responses ahead of the meeting** 

#### 07.24.11 Maintenance of the Secret Garden

The Pound (secret garden) until the early 1990s was Allotments but due to lack of use was turned over to the village. CDC paid for it to be turned into the Secret Garden, The PC no longer maintain it – the trustees of the charity have custody of the land. It was proposed that the PC take over the maintenance of the land. It was agreed that the PC will register ownership of the land when permitted to by 'CDC and will undertake the maintenance.



NO has asked CDC Common Land Department about registering common land and was told that there is no common land in Souldern, and that legislation does not permit registration of land and asked Cllr McHugh to clarify.

## 07.24.12 Drainage/Flooding/Sewage

Cllr McHugh had provided a document identifying the issues within Souldern. Some amendments were made and the document will be re-drafted. Cllr McHugh had spoken to Environmental Services at CDC but had no response yet. NO had spoken to the manager of McDonalds and was told that there had been a spike in issues due to a maintenance issue and no further incidents are predicted.

#### 07.24.13 Swing Bridge

HD is discussing with Katy Draper who has had a letter from Countryside Officer at CDC who has advised that CDC have sent a statement indicating that they are no longer to assist with the matter.

'The public right of way over the towing path, bridges and other property of the British Waterways Board is subject to, and conditional upon, the exercise of the Board's powers and duties, including the right to obstruct and close the said right of way whenever required for the purposes of navigation, engineering and maintenance operations and in connection with authorised uses of the canal'

HD will respond to CDC pointing out that this problem is affecting the livelihood of a local farmer and that the problem needs to be resolved.
